VIDEO VISITATION RULES FOR ON-SITE VISITATION

- 1) On-Site visits may be scheduled 24 hours in advance by the visitor from the Securus Video Visitation Website at <http://videovisitation.securustech.net/onsite>, or scheduled at the **Beaver County Jail**.
- 2) Visitors must present a valid, government issued photo identification.
- 3) On-Site visitors may be subject to search of person.
- 4) The duration of each visit is 20 minutes; each inmate is allowed one (1) on-site visit per month.
- 5) No more than two visitors present for each visit.
- 6) All visits are recorded and subject to electronic monitoring by the Beaver County Jail Staff.
- 7) Every visitor that scheduled their visit in advance must show up at least 15 minutes prior to your scheduled visit and no more than 30 minutes prior to your scheduled visit. Visitors arriving late will only receive the balance of the remaining visiting time, or may not be allowed to visit at the discretion of Visitation staff.
- 8) Violators of 8a through 8d will be barred from off-site and on-site visitation:
 - a) Tight Fitting, Provocative, or See-Through Clothing is prohibited.
 - b) Nudity, Partial Nudity, Sexual Acts, Simulated Sexual Acts, or depiction thereof is prohibited.
 - c) Security Threat Group (STG) or Gang Activity, Signage, Symbols, or other Representation of any such group is prohibited.
 - d) Any Illegal Activity, Conspiracy to Commit an Illegal Act, or depiction thereof is prohibited.
- 9) Visitors appearing to be under the influence of alcohol or drugs are subject to having the visit cancelled and barred from future visits.
- 10) During a visit, the visitor is required to remain at the visitation booth. If the visitor leaves the visitation booth, the visit will be terminated.
- 11) Visitors under the age of 18 must be accompanied by a parent or guardian.
- 12) Visitors may only bring their identification and car keys into the visitation area. Cell phones, cameras or other electronic devices are prohibited. No purses, diaper bags, briefcases, etc.
- 13) Loud talking or any type of disruptive behavior will not be permitted.
- 14) Do not damage or deface the visitation equipment. Doing so may result in prosecution.
- 15) If you experience a problem with the audio or video reception during your visit, you are required to notify the visitation staff immediately.

- **Inmates on work detail will not be allowed to leave the detail for a friends/family video visit.**
- **Inmates in the BRT Program may only visit as indicated in the schedule above.**

The Beaver County Sheriff's Office reserves the right to deny, cancel or terminate a video visit prior to or during a video session based upon visitor or inmate misconduct. The Beaver County Sheriff's Office also reserves the right to restrict a visitor from participating in all future use of the system, either on-site or for remote visitation.
